Baroda U.P. Bank a leading Regional Rural Bank sponsored by Bank of Baroda wishes to buy insurance cover through tendering process for its employees in the wake of Covid-19.

Details are as under: -

Insurance Coverage Details: -

1. The **Purpose** of this process is to seek quotation for compensation to be paid on account of death of an employee who is COVID – 19 positive.
2. **Policy Type** – Group Policy on named basis
3. **Group Size:** - 8665 (Tentative)
4. **Sum Insured:** - Rs 20 Lac per Employee
5. **Cover Required:** - Death only. Company will entertain/pay the death claim of Insured person (who's premium is paid by respective cooperative institution in advance before starting the risk) for COVID-19 positive cases during entire policy period.
6. **Age:** - Entry age of employees is up to the age of 60 years.
7. **Policy Period:** - One year from policy inception date.
