- Payment will be made by regional office after successfully work completion at all branches/offices subjected to the satisfactory report of work.
- Minimum one visit of each branch for refilling of fire extinguisher and training for handling of fire extinguisher. (Visit certificate to be countersigned by the branch authority is mandatory).


Other terms and condition :

- The registration no. of the firm along with the GSTIN no. allotted by the authorities must be submitted.
- PAN no. of the firm allotted by the Income tax authorities must be submitted. (Without PAN and GSTIN registration the vendor's bid would become invalid and same shall be rejected).
- Conditional tenders shall not be accepted on any ground and shall be rejected straight away.
- Any deviation of the conditions given by the vender will not be accepted and the tender will be rejected without assigning any reason.
